The West Bengal Police Recruitment Board in **cancellation** of its earlier Notice bearing **No. WBPRB/NOTICE - 07/2020 (CS - 20)**, is inviting applications from male Indian citizens for recruitment of **Sub-Inspector (Crew Comprising Master)**, **Assistant Sub-Inspector (Crew Engine Driver)** and **Constable (Crew)** for operating Fast Interceptor Boats/Flat Bottom Vessels/Water Scooter (Jet Ski) of Coastal Police Stations under Coastal Security Scheme (Phase - I & Phase - II). Male candidates retired from Indian Navy/Indian Coast Guard/BSF Water Wing/Indo Tibetan Border Police (Water Wing) having following eligibility criteria are eligible to apply for the posts.
