It is for information of all concerned that, on the basis of the Main written examination held on 24.08.2021, for recruitment to the posts of Assistant Executive Engineer (Civil) in Odisha Panchayati Raj Engineering Service, under Department of Panchayati Raj & Drinking Water, pursuant to the Advertisement No. 04 of 2020-21, 405 (Four hundred five) candidates bearing following Roll Numbers have been qualified & shortlisted for admission to the viva voce test. The physical verification of original certificates, documents etc. & Viva Voce test in respect of above qualified candidates, will be conducted simultaneously in the office of the Commission at 19, Dr. P. It is also made clear that the candidature of these candidates for the recruitment is **purely provisional.** The candidature is liable to rejection in the event of inadequacy /deficiency found at any stage before or after the verification of original certificate /documents and is subject to fulfillment of terms and conditions laid down in the advertisement.

Mere participation in the document verification does not reserve any right to appear the viva voce test. The candidates shall be scheduled date & time mentioned below subject to respect as per verification of original certificate Commission thereon shall be final.

Special instructions & guidelines for candidates in view of Covid-19

- a). Covid-19 test report (**RT-PCR**) showing "negative" (-ve) obtained from authorized laboratories of ICMR within 72 hours of the date of document verification to be brought by all candidates. No candidate shall be permitted for document verification & viva voce test, if Negative RT-PCR report not furnished.
- b). The candidates should bring their own water bottles.
- c). Each candidate should carry his/her own sanitizer bottle and wear mask properly. No candidates shall be permitted to the document verification & viva voce test without proper masking.

Each candidate should maintain social distancing norm of 6 feet while coming to the verification process & viva voce test.
